

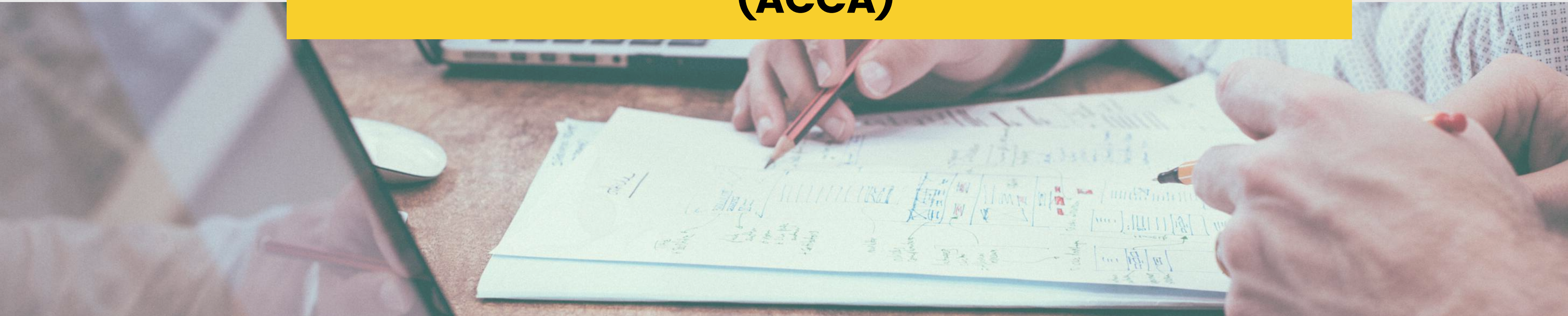

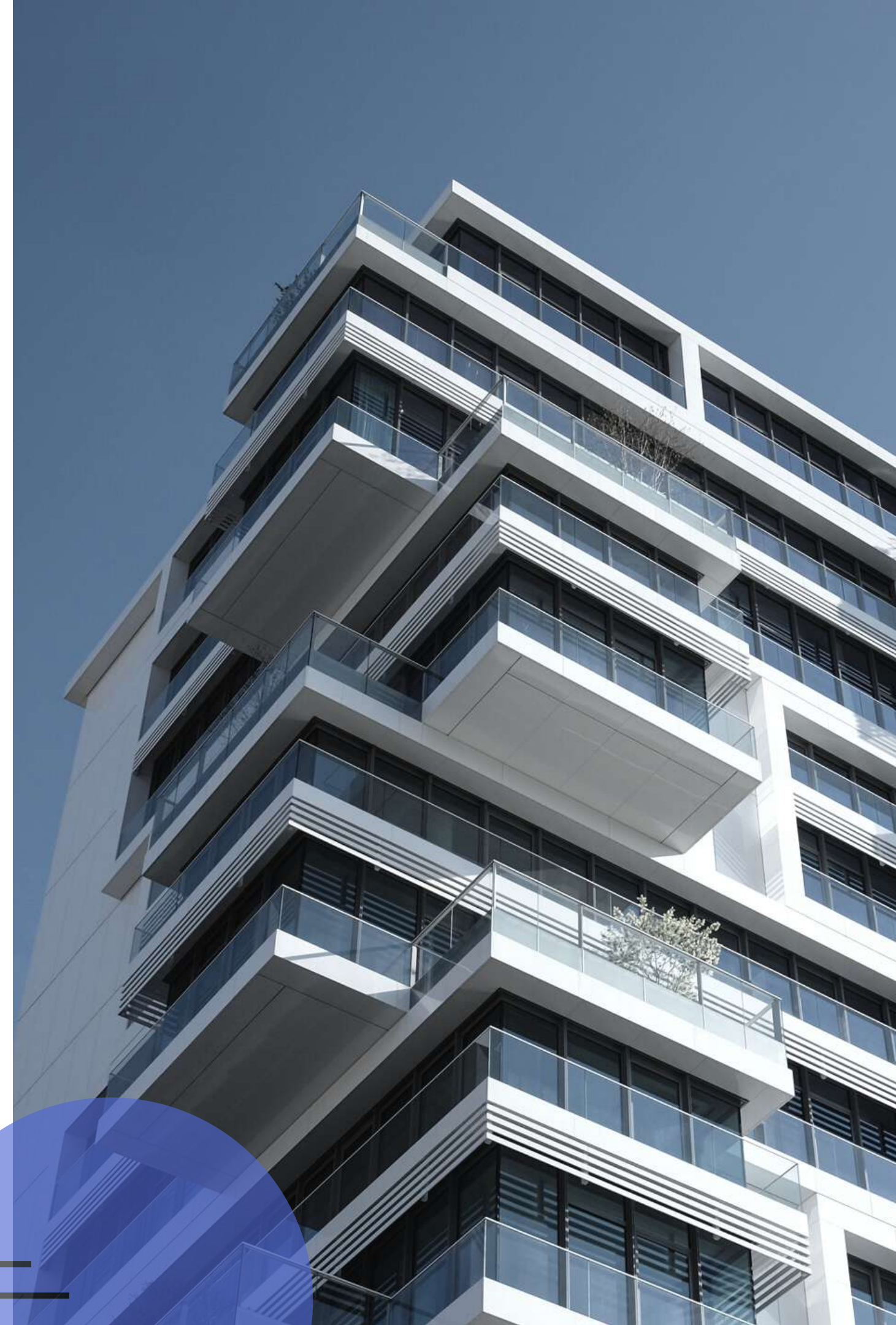

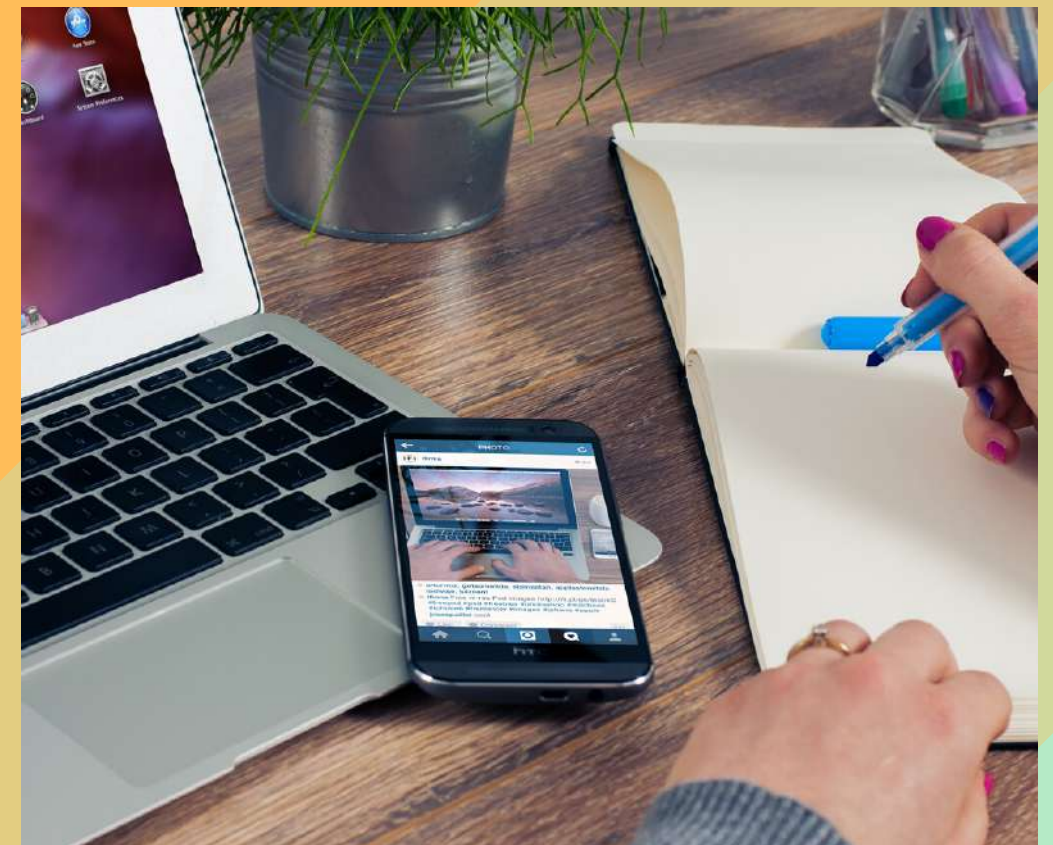
COURSE STRUCTURE:

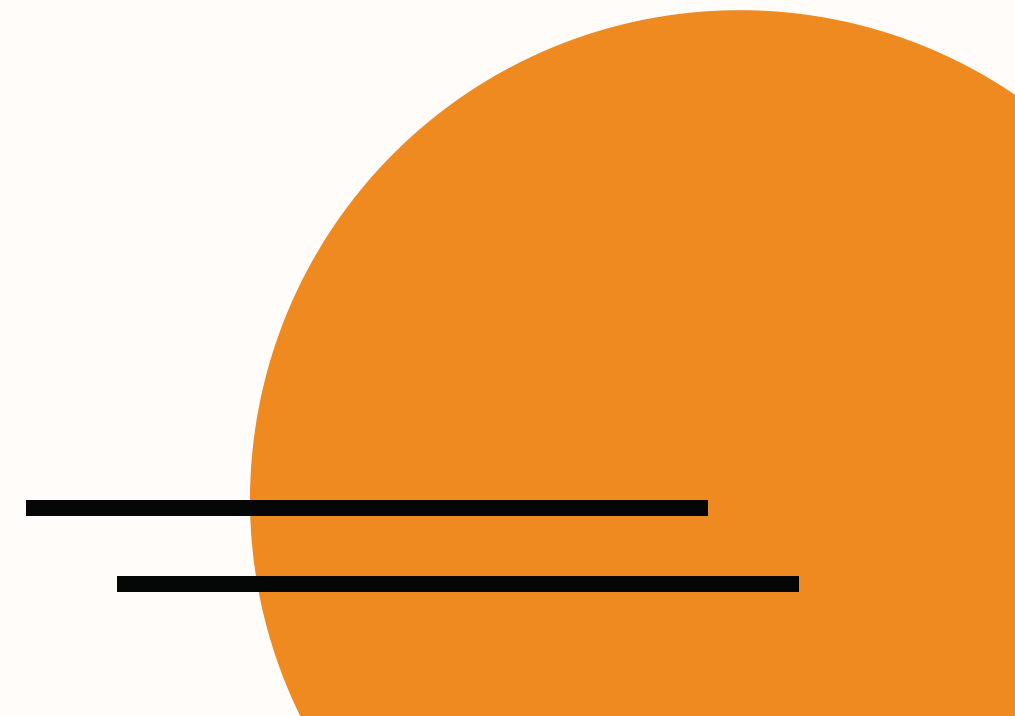
