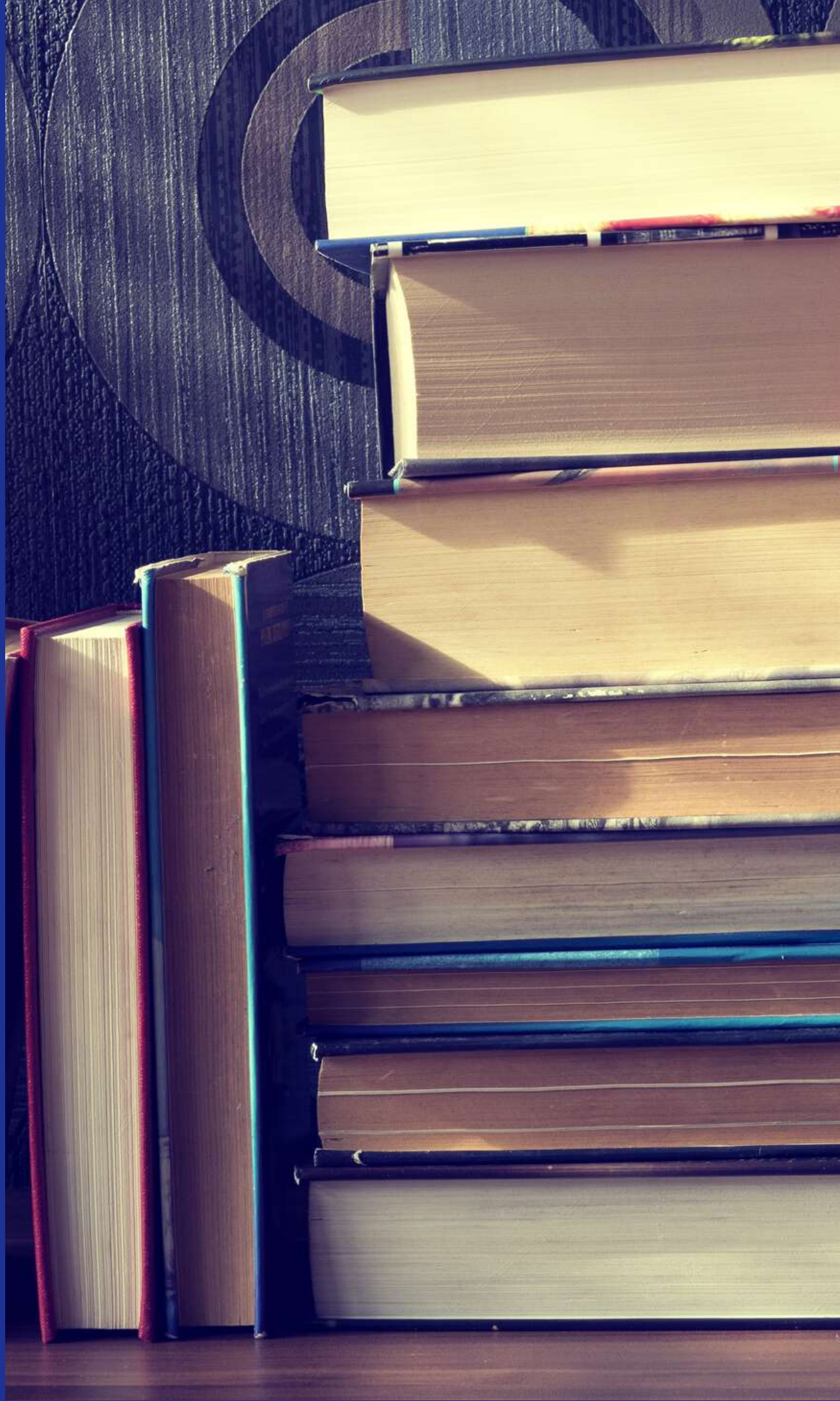


ABOUT THE GARP

MINIMUM ELIGIBILITY CRITERIA

A graduate is eligible to give the exam and should have 2 years of relevant work experience. FRM Exam is of two parts and exams are conducted in the months of May and November on 3rd Saturday.

The only prerequisite to register for the exams is for the candidate to have a valid current government issued photo id (such as: passport)

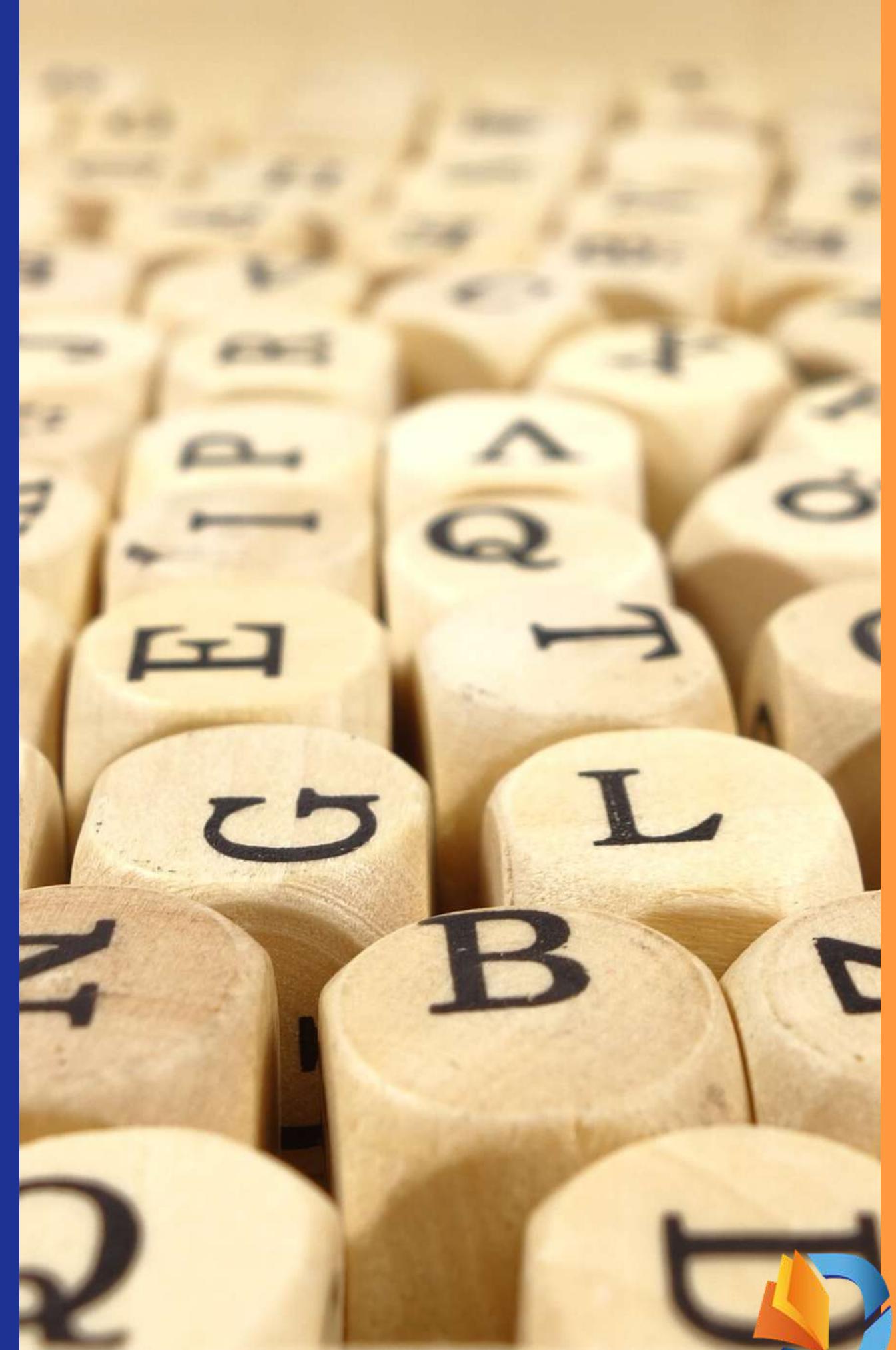

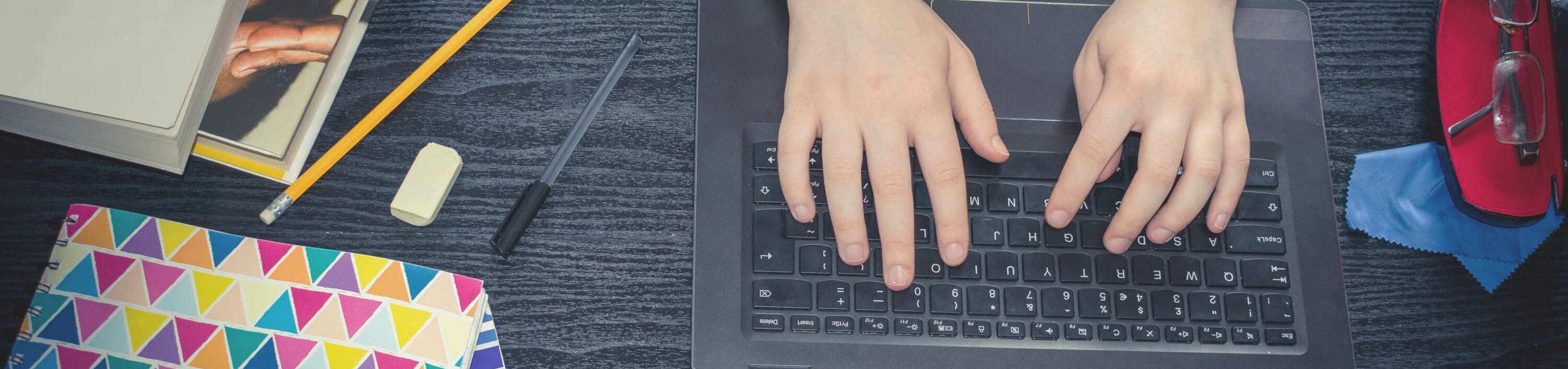

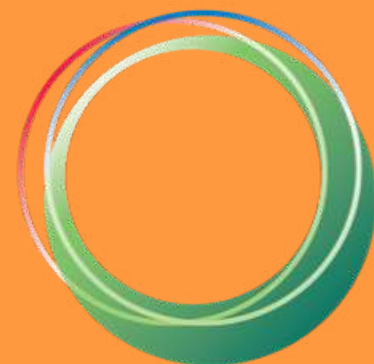
